Jean Monnet Fellowships

Deadline: 25 October 2024

The European University Institute offers one-year Jean Monnet Fellowships to scholars to become a part of lively and creative academic community. The Fellowship programme is open to post-docs, tenure-track academics and those wishing to spend their sabbatical at the Centre. Jean Monnet Fellows are selected on the basis of a research proposal and of their CV. The research proposal should fit well with one of the Centre's main research themes, programmes and projects.

Jean Monnet Fellows are based at the Robert Schuman Centre and associated with one of the Centre's projects and programmes. They are expected to actively participate in the academic life of the Centre and contribute to the activities of the project or programme they are associated with. They can take part in the activities of the EUI postdoctoral programme and are encouraged to collaborate with researchers, other postdocs and EUI academic staff.

Funding Information:

- The basic grant is € 2,500 per month.
- Successful applicants who receive other grants or salaries must disclose this to the EUI. The amount of the Fellowship will be fixed at a lower rate (minimum €1,750 per month) depending on the amount of the additional income (upon production of relevant supporting documents).
- **Duration:** The fellowships are for the duration of one year (12 months from September to August).

Conditions of Award:

- **Residence:**
 - Fellows must live in the area of Florence for the duration of their Fellowship so that they can take an active part in the academic activities of the Robert Schuman Centre for Advanced Studies.
- **Publication:**
 - The research done during the fellowship should lead to a publication, either as an EUI Working Paper, or in a scientific journal, or with a reputable academic publisher.
- **Family allowance:**
 - A household allowance of up to € 300 per month is paid to Fellows with a partner if the partner lives with them in Florence and on condition that the partner's income is less than € 2,000 per month. The sum of income and allowance cannot exceed € 2,000 per month (i.e. if the income is more than € 1,700, the allowance will be paid only to top up to € 2,000).
 - There is a dependants allowance of € 200 per month for each dependent child if they live with the fellow in Florence.
 - Fellows are entitled to these allowances if they can declare that they are not receiving any similar allowance from another source, and upon production of relevant documents (marriage certificate or a document that proves you are living together in Florence, birth certificates).
 - For dependent children in full-time education and over the age of 18, a school or university certificate is required. No allowance is paid for dependent children over the age of 26.

- **Taxation:**
 - The fellowship is not taxed by the Institute. Fellows are, however, required to comply with any other tax provisions which may be applicable to them.
- **Medical insurance:**
 - Fellows must have adequate medical insurance cover during their stay at the Institute. They can either provide proof of their own insurance scheme or subscribe to the EUI's private sickness and health insurance scheme at their own expense.
- **Travel expenses:**
 - Fellows (but not their families) receive reimbursement for the incoming trip from their place of origin to Florence, and for the outgoing trip to their destination at the end of their fellowship.
 - First-class rail (travel by car is also reimbursed on this basis)
- **Economy class air fare:**
 - The maximum amount for travel reimbursement is €1,200 including both incoming and outgoing trip. Reimbursement of higher amounts and any extra costs can be authorized by the Centre Director upon a justified special request. Taxi expenses are not reimbursed.
- **Removal/installation expenses:**
 - There is no provision for removal or installation expenses.

Eligibility Criteria:

- The fellowships are open to candidates who have obtained their doctorate more than 5 years prior to the start of the fellowship on 1 September (to apply for 2025-26, the Ph.D. should have been awarded before 1 September 2020).
- Candidates of all nationalities are eligible for the Jean Monnet Fellowships.

Fernand Braudel Senior Fellowships

Deadline: 30 September 2024

The European University Institute is inviting applications for the Fernand Braudel Senior Fellowships to provide a framework for established academics with an international reputation to pursue their research at the EUI.

Fellowships last for up to ten months in one of the EUI's four Departments which in turn invite fellows to participate in departmental activities (seminars, workshops, colloquia, etc.).

Fellows, while in residence at the EUI, are encouraged to make contact with researchers sharing their academic interests, may be involved in the teaching and thesis supervision tasks of EUI professors, and associated with one of the research projects being carried out at the EUI.

Funding Information:

- The monthly stipend is € 3,000. The amount of the grant for successful applicants whose normal place of residence is within 90 km of Florence will be fixed at a lower rate.

Conditions of Award:

- **Duration and Residence:**
 - The fellowship lasts up to 10 months. Candidates must indicate their intended length of stay in the application, but the hosting department may propose a different and/or shorter period to successful candidate subject to available funding. Fellowships are not normally awarded for the months of July and August.
 - Fellows must live in Florence for the duration of the fellowship so that they can take an active part in the academic activities of their department.
- **Medical Insurance:**
 - Fellows must have adequate medical insurance cover during their stay at the Institute. They can either provide proof of their own insurance scheme or subscribe to the EUI's private sickness and health insurance scheme at their own expense.
- **Travel and Removal/Installation Expenses:**
 - There is no provision for travel expenses. There is no provision for removal or installation expenses.

Eligibility Criteria:

- The fellowships are open to established academics with an international reputation. Former professors or fellows of the EUI are eligible after three years have elapsed since their last contract with the EUI.
- Candidates of all nationalities are eligible.
- Fellows should have a good knowledge of English and of any other language relevant to their proposed research.

I Tatti Wallace Fellowship Program for Scholars

Deadline: 15 November 2024

I Tatti is currently accepting applications for the Wallace Fellowship program designed for scholars who explore the historiography and impact of the Italian Renaissance in the Modern Era (19th-21st centuries).

Projects should address the transnational dialogues between Italy and other cultures (e.g. Latin American, Mediterranean, African, Asian etc.) during the Renaissance, broadly understood historically to include the period from the 14th to the 17th century. I Tatti offers Fellows the precious time they need to pursue their studies with a minimum of obligations and interruptions together with a maximum of scholarly resources—a combination that distinguishes the Harvard Center from similar institutions. Each year, a limited number of activities organized at I Tatti are reserved for the Fellows, and they are expected to join the wider community at conferences, lectures, and concerts.

Funding Information:

- The grant is USD 5,200 per month, plus a one-time supplement (maximum USD 1,800) towards relocation expenses. In light of the residential nature of the fellowship Fellows must live in the Florence area and spend at least three days a week at the center. When possible, an apartment will be set aside for the Fellow's use, rent free, but with charges for utilities. If an apartment is not available, a housing subsidy will be offered to help offset rental costs.
- This is a residential fellowship of 4 or 6 months in length. Up to four fellowships will be awarded every year.

Eligibility Criteria:

- At the time of application, scholars must have a PhD in hand and will be asked to upload a scan of the certificate. They may not be working on a second PhD at the time of application. The proposed research project may represent a segment of a larger project.
- Applicants must be conversant in English and have familiarity with Italian. Priority will be given to early and mid-career scholars. Projects can address the historiography or impact of the Renaissance on any field, including art and architecture, landscape architecture, history, literature, material culture, music, philosophy, religion, and science. It must be possible for applicants to carry out most of their research in Florence.
- I Tatti welcomes applications from scholars from all nations and gives special consideration to candidates without regular access to research materials and facilities in Italy.
- Short-term Fellowships at I Tatti can be held only once and cannot be deferred. Short-term Fellowships are intended for scholars who have not previously held appointments at I Tatti (with the exception of Graduate Fellows).
- Applications are evaluated by international scholars.
- The selection committee aims to assess the ability of candidates to contribute in a collegial way to the intellectual life of the Harvard Center. It pays special attention to the strength of the proposed project and its potential to yield original results, and to the candidate's curriculum vitae.

Berenson Fellowship Program

I Tatti, in partnership with The Lila Wallace – Reader’s Digest Fund, is inviting applications for the Berenson Fellowship program designed for scholars who explore “Italy in the World.” Projects should address the transnational dialogues between Italy and other cultures (e.g. Latin American, Mediterranean, African, Asian etc.) during the Renaissance, broadly understood historically to include the period from the 14th to the 17th century.

It is named after Bernard Berenson, who in his 1956 statement ‘On the Future of I Tatti’ expressed the hope that not only would scholars come from many countries, but that they would also travel in “what was the ancient Oecumene, not going farther East than the Euphrates and not farther South than Egypt and the great desert of North Africa” and be intimately acquainted with the Mediterranean countries and their “Hinterland.”

I Tatti offers Fellows the precious time they need to pursue their studies with a minimum of obligations and interruptions together with a maximum of scholarly resources—a combination that distinguishes the Harvard Center from similar institutions. Each year, a limited number of activities organized at I Tatti are reserved for the Fellows, and they are expected to join the wider community at conferences, lectures, and concerts.

I Tatti Fellowship in the Digital Humanities

Deadline: 15 November 2024

The I Tatti fellowship in the Digital Humanities aims to support the work of scholars in the humanities or social sciences, librarians, archivists, and data science professionals whose research interests or practice cut across traditional disciplinary boundaries and actively employ technology in their work. Projects can address any aspect of the Italian Renaissance, broadly understood historically to include the period from the 14th to the 17th century, and geographically to include transnational dialogues between Italy and other cultures (e.g. Latin American, Mediterranean, African, Asian, etc.). Projects should apply digital technologies such as mapping, textual analysis, visualization, or the semantic web to topics in fields such as art and architecture, history, literature, material culture, music, philosophy, religion, and the history of science.

I Tatti offers Fellows the precious time they need to pursue their studies with a minimum of obligations and interruptions together with a maximum of scholarly resources- a combination that distinguishes the Harvard Center from similar institutions. Each year, a limited number of activities organized at I Tatti are reserved for the Fellows, and they are expected to join the wider community at conferences, lectures, and concerts.

Funding Information:

- The grant is USD 5,200 per month, plus a one-time supplement (maximum USD 1,800) towards relocation expenses. In light of the residential nature of the fellowship Fellows must live in the Florence area and spend at least three days a week at the center. - Candidates should possess the technical skills to carry out their project at the time of application, and it must be possible for applicants to carry out most of their research in Florence.
- The proposed research project may represent a segment of a larger project.
- Priority will be given to early and mid-career scholars.
- I Tatti welcomes applications from scholars from all nations and gives special consideration to candidates without regular access to research materials and facilities in Italy.

The Institute supports innovative research projects through individual and group fellowships. FRIAS provides modern office spaces and an up-to-date infrastructure and makes every effort to provide tailor-made solutions with regard to suitable accommodation, childcare and educational facilities.

What they offer?

- Depending on their situation, selected applicants will receive a fellowship contract with the University of Freiburg or other compensation.
- Fellows receive a research cost contribution, a budget for individual training, a mobility allowance (if applicable) and travel costs of the inbound and the outbound journey (if applicable).
- Fellowships will allow researchers to conduct their own research projects. Since one of the aims of FRIAS is to foster cross-disciplinary communication, full-time presence at FRIAS is mandatory.

Eligibility Criteria:

- Fellowships are available to researchers from any nationality based in Freiburg, Germany and abroad for 3 to 8 months between September 1st, 2025 and August 31st, 2026.
- Applicants must hold a doctoral degree.
- Applicants must have a minimum of eight years of post-doctoral research experience.
- Applicants must have six months' research or study experience at academic institution(s) in a country different from the country of their first academic degree by the time of application or have received a Master/PhD in a country different from the country of their first academic degree by the time of application. Short stays, such as holidays, conferences, or summer schools are not considered.
- Applicants must propose a research project that can be supported at the University of Freiburg (regarding infrastructural, technical, and laboratory requirements). Experimental scientists are required to identify a host laboratory in Freiburg (including letter of support).
- The research project must not involve topics that are excluded from funding due to ethical issues.
- There is no age limit for applying to the FRIAS Senior Fellowship Programme although the candidates' achievements should be in line with their "academic age".

Selection Criteria:

- Applicants must have a completed PhD plus a minimum of eight years of post-doctoral experience.
- 10 peer-reviewed publications since 1 January 2018.
- Applicants must have six months' research or study experience at academic institution(s) in a country different from the country of their first academic degree

Selection Criteria:

- Applicants must have a completed PhD plus a maximum of eight years of post-doctoral experience. 4 peer-reviewed publications since 1 January 2020.

Camargo Fellowship 2025-2026

Deadline: 1 October 2024

The Camargo Foundation is inviting applications for the Camargo Fellowship Program to support groundbreaking research, experimentation, and interdisciplinary approaches in the Arts and Humanities.

The Camargo Fellowship not only provides time and space for the residents, but also initiates exchanges within the group and develops a collective spirit, which is one of the program's distinctive features. The interactions developed among the program's fellows are a vital element of this program.

The selected applicants are awarded residencies in a stunning, contemplative environment where they have the space, time, and freedom to think, create, and connect. With each cohort of Fellows, the Foundation strives to foster connections between research and creation.

The Camargo Foundation is committed to supporting inclusiveness and a diversity of contemporary reflections and practices, welcoming applicants from around the globe. The Camargo Fellowship offers research-based residencies to applicants from various fields and disciplines. Three main categories are available, as well as several subcategories for artist applications.

Purpose of the Residency:

- **Research, Experiment & Create:**
 - Applicants must submit a proposal for work they would like to accomplish during their residencies. Proposals may include specific projects to develop or complete (e.g. a book, film, composition, artwork, etc.) or research into a particular topic or issue, in advance of writing or creating a work of art. Research projects should be pertinent to the Fellow's field. The Camargo Fellowship welcomes both open-ended exploration and more focused works.
- **Resident Session:**
 - Residents' sessions are conceived and held by the residents throughout the Camargo Fellowship's duration. They aim to gather fellows around questions/activities relating to a resident's specific research/practice. Residents' sessions are invitations to discover a resident's universe and to engage with it collectively. These sessions can be organized at the foundation or off campus, and can be of any format (performances, walks, listening, screening and/or reading sessions, game, discussion). Every fellow will have to conceive and lead their own session. Attendance to these meetings is mandatory for residents from the Camargo Fellowship. They can be organized at the foundation or off campus and be of any format.
 - They encourage residents to avoid classic (PowerPoint) presentations, to rather experiment with more interactive ways of engaging with each other. Attendance to these sessions is mandatory.
 - The Camargo Foundation's staff can provide formal and informal links to the region, facilitate meetings with professionals whose areas of expertise are relevant to Fellows' work, and communicate opportunities to attend events or invite outside professionals to project discussions.

Duration, Stipend and Accommodation:

- **Residency Periods:** The Camargo Fellowship consists of fellowship residencies that span a period of 10 weeks. The dates for 2025-2026 are:
 - Fall 2025 10 weeks from September 10 to November 19, 2025

- Spring 2026 10 weeks from February 24 to May 5, 2026
- **Number of 14 Fellowships:** per year (7 artists and 7 scholars & thinkers).
- **Stipend:** A stipend of EUR 350 per week is provided (EUR 3500 for the entire duration of the residency), as is funding for basic transportation to and from Cassis per Fellow. In the case of air travel, basic coach class booked in advance is covered.
- **Additional Funding:** Fellows may not accept gainful employment that will prevent them from focusing on their project during their residencies at Camargo. Research leaves or other forms of sabbatical that provide income during the grant period are allowed, as are fees for occasional lectures or participation in seminars. Additional grants that do not contradict the conditions of the Camargo Fellowship are encouraged.
- **Workspaces & Facilities:** The Camargo Foundation's campus includes twelve furnished apartments, a reference library, a music/conference room, an open-air theater, one artist's studio with a darkroom, and one composer's studio with a piano. The Camargo Foundation does not have a dance studio. The facilities are ideal for desk work. The Camargo Foundation does not provide art supplies or technical equipment. All apartments include a fully equipped kitchen for residents to prepare their own meals.
- **Note for Visual Artists:** While Camargo can provide an artist studio, it is important to keep in mind that the Camargo Fellowship is a research-based residency, focused on research rather than production. The foundation does not cover shipping costs related to the transportation of artworks (to and from the foundation), or of any material work that might be produced during the residency.
- **Visas:** For non-European Union citizens, a visa may be required depending on nationality and length of stay. The processing of this visa may take a considerable amount of time. Fellows who are not from European Union countries should contact the French Embassy or Consulate in their area for information regarding visa requirements for France. The Camargo Foundation will provide an invitation letter if required.
- **Eligibility Criteria:** The Camargo Foundation is committed to supporting inclusiveness and a diversity of contemporary reflections and practices, welcoming applicants from around the globe. The Camargo Fellowship offers research-based residencies to applicants from various fields and disciplines. Three main categories are available, as well as several subcategories for artist applications.
- **Scholars:** in the Arts and Humanities should have a focus on French and Francophone cultures, or cross-cultural studies that engage the cultures and influences of the Mediterranean region. To be eligible for a fellowship in the "Scholars" category, applicants are expected either to hold a PhD and a record of post-doctoral scholarship, or to be PhD candidates completing the final stages of research for, or writing of, their dissertation.
- **Thinkers:** include accomplished professionals and practitioners in cultural and creative fields (such as curators, journalists, critics, urban planners, independent scholars, etc.) who are professionally engaged in critical thought. They are interested in work attuned to the theoretical arena, the arts, and society. Thinkers must develop reflections contributing to equitable transitions, and producing plural subjectivities.
- **Artists:** should keep in mind that the Camargo Fellowship is a research-based residency. Applicants should have maintained a (professional) practice for at

least the past 5 years. They should be the primary creators of new work or a new project. They should be able to demonstrate a track record of publications, public performances and exhibitions, credits, awards, and/or grants.

- They are interested in artists who have a fully developed, mature artistic voice. Applicants may include artists who are engaged in critical thought and research oriented projects. When applying, artists will have to identify among the following subcategories: Visual Artists/Choreographers, Theater Directors, and Performance Artists/Writers and Playwrights/Film, Video, and Digital Artists/Composers and Sound Artists/Multidisciplinary Artists.
- **Collaborative Projects:** Teams of up to three individuals are welcome to apply, including but not limited to interdisciplinary collaborative projects. One stipend and one travel grant are awarded to each member of the team, and one multi-bedroom apartment is assigned to the entire team. Collaborative teams must provide application materials for all members of the team, including CVs and work samples. A maximum of 2 collaborative projects per application cycle can be selected.
- **Translation Projects:** Professional translators are eligible to apply. Academic translators who meet the eligibility requirements for Scholars can apply under the Scholar category. Literary translators with a theoretical or research-oriented project are encouraged to apply under the Thinker category. Translators who frame their practice as creative writing can apply under the Writer category. Applicants are welcome to choose the category they prefer according to their specific project and profile.
- **Former Fellows:** may not apply until three years after their previous fellowship.
- **Residency Requirements & Obligations of The Fellow:** Work developed during the residency may be in any language. In the interests of Camargo's interdisciplinary, multicultural community, candidates must be able to communicate well in English. A basic knowledge of French is useful for daily life outside campus.
 - The time in Cassis must be spent on the project or area of inquiry proposed to and accepted by the selection committee and approved by the Camargo Board of Trustees.
 - Fellows must be physically in residence at the Camargo Foundation during the entire residency period. This stipulation does not preclude absences during weekends. Frequent or prolonged absences are not allowed.
 - Research should be at a stage that does not require resources unavailable in the Marseille-Cassis-Aix region or online. Applicants planning on conducting research in local archives may need to rent a car during their fellowship at their own expense.

The Norwegian Health Association is a voluntary, humanitarian organization working with public health, research into cardiovascular diseases and dementia and promoting the interests of people with dementia and their next of kin. The Norwegian Health Association has established a national, comprehensive and coordinated Dementia Research Programme.

Funding Information: The postdoctoral candidate is offered salary and running costs corresponding to three year's full position. Annual lump sum is 1 000 000 NOK/year (full position), whereas 100 000 NOK/year is intended for running costs. Running costs may include general costs related to the project (supplies, analyses, laboratory animals, equipment, relevant network building activities, conference fees, project specific services etc.).

- The candidate may apply for funding for the first or second postdoctoral period. If the position at the research institution has a higher total cost frame than the defined lump sum, the project owner institution must bridge the gap.
- The Norwegian Health Association does not offer overhead costs; thus, the project owner institution must cover all institutional costs beyond the granted amount.
- The project must start between January 1st and December 1st 2025. They recognize that in some cases there may be a need for a reduced research position. The project may therefore last for up to 72 months from start date.

It puts research and innovation at the heart of the UK's international relationships, supporting UK researchers and innovators to work with peers around the world on the major themes of our time. It is managed by the Department for Science, Innovation & Technology and delivered by a consortium of the UK's leading research and innovation bodies. In the context of this call, funding from the International Science Partnerships Fund is funded by ODA therefore applications for this funding must be ODA-eligible.

The aim is to have a mutually beneficial partnership between the fellowship award holder and partner organisation in creative and cultural, public, private and/or policy sectors with each able to take advantage of fresh perspectives and expand their networks and reach. It will enable the award holder to strengthen and create new links outside academia, enabling knowledge mobilisation and translation, and the opportunity to develop new approaches and solutions to societal, cultural, commercial and/or policy challenges through providing a different perspective.

Focus Areas:

- In this call applicants must apply with a partner which they have identified, and who will be designated the 'co-applicant'.
- This is an opportunity for award holders to form new collaborations and draw on the insights this brings to inform, influence and develop their future development. They seek open-mindedness, a willingness to explore new perspectives and to experiment with innovative approaches. You will have an appetite for working across academia, policy and practice, and will demonstrate a commitment to being genuinely challenge driven and dedicated to integrating the perspectives, needs and priorities of the partner organisation.

holder into the partner organisation and the wider location. This may include acting as the Lead Applicant's line manager or supervisor.

- The partner organisation must be based in at least one of the following countries: Brazil, Egypt, Indonesia, Jordan, Kenya, Malaysia, Philippines, South Africa, Türkiye, Thailand, Vietnam and/or any country from this list of Least Developed Countries. The Lead Applicant and Co-Applicant must be based at the partner organisation's office in one of these countries throughout the duration of the award.

The partner organisation must not be the same organisation at which the Lead Applicant is based.

Postdoctoral Fellowships in Humanities and Social Sciences (UK)

Deadline: 2 October 2024

The British Academy is inviting proposals from early career researchers in the humanities and social sciences wishing to pursue an independent research project, towards the completion of a significant piece of publishable research.

The British Academy Postdoctoral Fellowship offers outstanding early career researchers the opportunity to strengthen their experience of research and teaching in an academic environment. This scheme aims to help develop the award holder's curriculum vitae and boost their prospects of obtaining a permanent academic post. The primary emphasis is on the completion of a significant piece of publishable research, and the integration of the award holder into the community of established scholars within their field.

Funding Information:

- Postdoctoral Fellows will be employees of the institution at which they hold their award and are therefore subject to the terms and conditions of employment of that institution. The scheme is covered under the Full Economic Costing (FEC) regime. Currently, the Academy funds 80% of salary costs, directly allocated and indirect costs under FEC. Research expenses are covered at 100% within the upper limit, which is set at £6000 over the three years. The £6000 may be allocated unevenly between years.
- The initial salary will be expected to be commensurate with the early career stage of the applicant, and therefore equivalent to posts with similar duties and levels of responsibility within the host institution pay grades.

Eligibility Criteria: British citizens and any nationals from the European Economic Area are eligible, regardless of where their doctorate was obtained. Anyone of any nationality who has a doctorate from a UK university is eligible.

- If an applicant does not meet the prior categories, they may be accepted if they can demonstrate 'strong prior association' with the UK academic community. This typically means a current significant period – with a minimum period of one year, which will need to be completed prior to your application being submitted – of employment at a UK institution in either a teaching or research position which is not permanent. Postgraduate degrees (MA or MSc) do not count.
- Early Career Status: There is no age criterion for these awards. Instead, eligible applicants are expected to be at an early stage of their career. This is defined as being within three years from the date of your successful Viva Voce examination.
- This period extends from 1 April 2022 to 1 April 2025.
 - Exemption from this criterion may be granted for reasons occurring after the date of the viva voce examination such as: maternity leave, illness, family commitments etc.
- The applicant must already be of postdoctoral status at the time when the Research Awards Committee meets. Applicants who expect to have had their viva by 1 April 2025, are eligible for consideration, but will have to withdraw their application if the examination is not completed on time.
- No applicant who has been appointed to a permanent academic post in an institution of higher education at any time in their career, whether in the UK or overseas, will be eligible. This includes positions held before the award of a doctorate.
 - Exemption from this condition will generally be granted if an applicant has held a permanent role of less than 0.5 FTE.

- The British Academy does not allow for resubmissions for the Postdoctoral Fellowship. If you have previously applied and failed to reach the Second Stage of the competition, you are not eligible to re-apply. Previously unsuccessful applicants will only be able to submit another application if specifically invited to do so by the British Academy.

Open call for Postdoctoral Fellowships

Deadline: 11 September 2024

The objective of PFs is to support researchers' careers and foster excellence in research. The Postdoctoral Fellowships action targets researchers holding a PhD who wish to carry out their research activities abroad, acquire new skills and develop their careers. PFs help researchers gain experience in other countries, disciplines and non-academic sectors.

Types of Postdoctoral Fellowship: There are 2 types of Postdoctoral Fellowships:

- European Postdoctoral Fellowships. They are open to researchers moving within Europe or coming to Europe from another part of the world to pursue their research career. These fellowships take place in an EU Member State or Horizon Europe Associated Country and can last between 1 and 2 years. Researchers of any nationality can apply.
- Global Postdoctoral Fellowships. They fund the mobility of researchers outside Europe. The fellowship lasts between 2 to 3 years, of which the first 1 to 2 years will be spent in a non-associated Third Country, followed by a mandatory return phase of 1 year to an organisation based in an EU Member State or Horizon Europe Associated Country. Only nationals or long-term residents of the EU Member States or Horizon Europe Associated Countries can apply.
- Both types of fellowships may also include short-term secondments anywhere in the world during the fellowship (except during the return phase of a Global Fellowship).
- In an effort to build bridges between the academic and non-academic sector, researchers can receive additional support to carry out a placement of up to 6 months in a non-academic organisation based in an EU Member State or Horizon Europe Associated Country. This placement needs to take place at the end of their fellowship.
- For Postdoctoral Fellowships in research areas covered by the Euratom Research and Training Programme, researchers need to be nationals or long-term residents of an EU Member State or a Euratom Associated Country. The beneficiary organisation recruiting the researcher also needs to be established in an EU Member State or Euratom Associated Country.

What does the funding cover: The beneficiary receiving EU funding needs to recruit the researcher for the total period of the fellowship.

- The EU provides support for the recruited researcher in the form of
 - a living allowance
 - a mobility allowance
 - if applicable, family, long-term leave and special needs allowances
- In addition, funding is provided for
 - research, training and networking activities
 - management and indirect costs

Who can apply for Postdoctoral Fellowships: Interested researchers submit an application together with a host organisation, which can be a university, research institution, business, SME or other organisation based in an EU Member State or Horizon Europe Associated Country. All disciplines are eligible for Postdoctoral Fellowships, including research areas covered by the Euratom Research and Training Programme.

- Researchers interested in PFs
 - should have a PhD degree at the time of the deadline for applications. Applicants who have successfully defended their doctoral thesis but who

have not yet formally been awarded the doctoral degree will also be considered eligible to apply

- must have a maximum of eight years experience in research, from the date of the award of their PhD degree, years of experience outside research and career breaks will not count towards the above maximum, nor will years of experience in research in third countries, for nationals or long-term residents of EU Member States or Horizon Europe Associated Countries who wish to reintegrate to Europe
- should comply with mobility rules: they must not have resided or carried out their main activity (work, studies, etc.) in the country of the beneficiary (for European Postdoctoral Fellowships), or the host organisation for the outgoing phase (for Global Postdoctoral Fellowships) for more than 12 months in the 36 months immediately before the call deadline.

Novo Nordisk Foundation Postdoctoral Fellowships for Research

Funding Information:

- The grant period is 1-3 years.
- The total grant amount is up to DKK 3 million for a 3-year grant.
- The grant amount should be distributed approximately equally each year, and for projects shorter than three years, the total grant amount is proportionally reduced.
- Please note, at least 1 year must take place at the Nordic host institution. The duration of the fellowship should reflect the time frame of the research activities.

Eligibility Criteria:

- An applicant must either:
 - Have a PhD or equivalent degree obtained within 6 years of the application deadline date, or
 - Be a PhD student who will defend her/his/their thesis before April 1, 2025.
- As part of the application, applicants need to submit a host letter from the Nordic host institution and letters of support from other institutions supporting the fellowship.

National Glaucoma Research Program

Deadline: 31 October 2024

The Bright Focus Foundation is providing research funds for U.S. and international researchers pursuing pioneering research leading to greater understanding, prevention, and treatment of glaucoma. Bright Focus is committed to supporting scientists from diverse backgrounds to foster creativity and innovation in addressing complex scientific challenges. They strongly encourage applications from individuals who are from groups underrepresented in the field of glaucoma research.

Award Categories: The NGR program offers two types of awards:

▪ **Standard Awards:**

- The goal of the Bright Focus Foundation research grants program is to advance innovative research promoting advances in the etiology, prevention, and treatments of Alzheimer's disease, macular degeneration, and glaucoma. The Foundation is interested in supporting high risk studies that illuminate areas for which there currently is little understanding, helping to bring to light crucial knowledge about these three devastating diseases.
- This is accomplished by relatively small grants for investigator-initiated research that are designed to allow scientists the opportunity to develop the preliminary data necessary to be considered competitive for larger government or corporate types of sponsorship. The focus of the program is on projects that, although associated with high risks, will offer high yields in terms of growth of the field. More incremental proposals, or proposals that might be easily funded through existing resources, are discouraged. While prior awardees are welcome to submit new proposals following the conclusion of the previously-sponsored project, the new proposals should not be extensions of the prior project.
- The standard award provides significant funding for researchers who have already generated some amount of preliminary data, but are often required to demonstrate additional, significant progress before they can apply to governmental or industrial funding agencies.

▪ **Postdoctoral Fellowship Awards:**

- This fellowship is available to researchers within four years of degree conferral or end of residency or fellowship. Exceptions to the above four-year eligibility period will be considered under unusual circumstances. Candidates must submit a written exception request to BrightFocus and obtain approval before applying. The application for this fellowship must be written by the intended fellow in conjunction with the mentor/laboratory head where the fellowship will be conducted. The application should be submitted through the business office of the institution where the fellowship will take place. Should the fellowship support be funded, the award is for support of the fellow and not for the mentor directing the research.
- This award is intended to support the fellow's salary, health insurance and travel to attend a scientific meeting each year to present BrightFocus-funded research.

- Postdoctoral fellowship awards are intended for young researchers in their final stages of mentored training. These awards fund projects in an established laboratory that will serve as the basis for the applicant's own independent research career.

Funding Information:

- **Standard Awards:** Award Amount: \$200,000 for 2 years
- **Postdoctoral Fellowship Awards:** Award Amount: \$150,000 for 2 years

Eligibility Criteria:

- **Standard Awards:** Standard Awards are open to tenure- and non-tenure track investigators of any career stage who are appropriately trained to lead an independent research study and are permitted by their organizations to manage grants and supervise key personnel. Specific eligibility criteria include:
 - Candidates must hold an MD, PhD, DVM, DO, OD or equivalent degree
 - Applicant must serve as the Principal Investigator on the project and have independent laboratory space. The applicant should use the indicated space on the application forms to clarify any position that is not immediately recognizable as an independent research position.
 - While some of the grant can be used to support salary for the PI, the percent requested should be limited to the lesser of 25% of the total grant request, or 25% of the individual's salary. Co-Principal Investigator (Co-PI) salaries are capped at the lesser of 15% of the total grant request, or 15% of the individual's salary.
 - Applicants may currently be working in a non-profit, governmental, academic research institution, or at a for-profit including start-up and biotech institution
- **Postdoctoral Fellowship Awards:** Specific eligibility criteria include:
 - Candidates must hold an MD, PhD, DVM, DO, OD or equivalent degree
 - Applicant may apply for this fellowship before completing their terminal degree, if they have a firm commitment from the laboratory head in which training will take place, and the applicant is the main author of the application
 - Fellowship may be performed in a non-profit, governmental, academic research institution, or at a for-profit including start-up and biotech institution
 - Previous recipients of this award are not eligible.

Radcliffe Fellowship Program

Applications are now open for the Harvard Radcliffe Fellowship Program for scientists, writers, scholars, public intellectuals, and artists, with an opportunity to step away from usual routines and dive deeply into a project.

Harvard Radcliffe Fellows benefit from a uniquely interdisciplinary and creative community that each year spans the sciences, arts, humanities, and professions. This diversity of approaches and expertise sets their program apart from other fellowship opportunities. With access to Harvard's unparalleled resources, Harvard Radcliffe Fellows can dive deeply into their projects while engaging with scholars, writers, and practitioners with whom they might not otherwise connect. Along with their cohort, Radcliffe Fellows join an exceptional network of alumni, making an impact in their professional fields and in the larger world.

Focus Areas: Climate change, especially proposals addressing critical questions of impact, equity and Academic freedom and connecting across difference.

Funding Information:

- Stipend
 - Fellows receive a stipend of \$78,000 plus an additional \$5,000 to cover project expenses. If instructed, Harvard Radcliffe Institute will pay the stipend to the fellow's US-based home institution. The stipend should be allocated entirely for salary and fringe benefits while the faculty member is in residence as a fellow at Harvard Radcliffe Institute. The Institute does not allow overhead to be charged on these payments. If the fellow's home institution is not US-based, the stipend will be paid directly to the fellow.

- Applicants in the creative arts must meet discipline-specific eligibility requirements, as outlined below:
 - Film and Video: Applicants in this discipline must have a body of independent work of significant achievement. Such work will typically have been exhibited in galleries or museums, shown in film or video festivals, or broadcast on television.
 - Visual Arts: Applicants in this discipline must show strong evidence of achievement, with a record of at least five years of work as a professional artist, including participation in several curated group shows and at least two professional solo exhibitions.
 - Fiction and Nonfiction: Applicants in these disciplines must have one of the following:
 - one or more published books;
 - a contract for the publication of a book-length manuscript; or
 - at least three shorter works (longer than newspaper articles) published.
 - Poetry: Applicants in this discipline must have had at least 20 poems or a book of poetry published in the last five years, and must be in the process of completing a manuscript.
 - Journalism: Applicants in this discipline are required to have worked professionally as a journalist for at least five years.
 - Music Composition: It is desirable, but not required, for applicants in music composition to have a PhD or DMA. Most importantly, the applicant must show strong evidence of achievement as a professional artist, with a record of recent performances.

Ineligibility Criteria:

- For 2025-2026, Getty invites scholars and arts professionals to apply for a residential fellowship on the topic of repair, a theme that bridges time periods, world geographies, and professional practices. Situated between the forces of creation and destruction, the act of repair can be deeply transformative, with the potential to heal, alter, and renew the material environment. Scholars are asked to think critically about repair, questioning interpretive assessments about the ideal state of any object or site, in addition to querying what constitutes damage or whether to repair the ruined or the broken. Beyond such physical interventions, art and sites of commemoration are often mobilized to heal a fractured social fabric. Indeed, art itself may be offered as reparation to address past wrongs or to recuperate loss. The issue of repair has deep bearing for the arts, conceived in the broadest sense, and especially for institutions that aim to preserve and share global cultural heritage.

United Nations-Nippon Foundation Fellowship

Deadline: 15 September 2024

The Division for Ocean Affairs and the Law of the Sea of the Office of Legal Affairs of the United Nations is now accepting applications for the 2025 session of the United Nations – The Nippon Foundation (UNNF) Fellowship Programme. The United Nations – Nippon Foundation Fellowship provides Government officials and other mid-level professionals from developing States with advanced training on ocean affairs and the law of the sea, as well as related disciplines, including marine science in support of management frameworks. Fellows will learn about international legal frameworks, key issues and best practices in ocean affairs, become familiar with the work of the United Nations, and develop professional skills. Fellows will also conduct individual research, under academic supervision, and develop a written thesis on a topic selected by them.

Upon completion of the Fellowship, Fellows are expected to return to their home countries and use their in-depth knowledge and extended experience to assist in formulating comprehensive ocean policy and in implementing the legal regime set out in the United Nations Convention on the Law of the Sea and related instruments, including through designing, implementing and/or evaluating specific improvement projects.

Fellowship Structure, Curriculum and Deliverables: The 9-month Fellowship Programme is composed of two consecutive phases which provide Fellows with advanced and customized research and training opportunities in their chosen fields:

- Phase One: 3-month Research and Training, which is normally undertaken between March/April and June at DOALOS at the United Nations Headquarters in New York.
- Phase Two: 6-month Advanced Academic Research and Study, which is normally undertaken between July and December at one of the prestigious participating Host Institutions and under the guidance of subject matter expert(s) who have recognized in-depth expertise in the Fellows' chosen field of study.
- The deliverables of the Fellowship Programme are:
 - A 100-page written thesis
 - A presentation of the research
 - An ocean governance matrix

Fellowship Offers:

- Stipend and book allowance
 - General
 - Fellows will receive a stipend each month during their Fellowship, both during their time in New York and, for United Nations – Nippon Foundation Fellows participating in the 9-month programme, during their time at the second phase host institution. The stipend is paid from the date a Fellow departs from their home country, and ends on the date of completion of the Fellowship, including a maximum travel time of up to two days by the most direct air route, in accordance with United Nations travel rules.
 - The stipend paid to Fellows while outside their home country is a monthly allowance intended to cover the cost of lodging, board and other essentials such as local transport. The stipend is normally payable in the local currency of the host country. The stipend is not a salary or honorarium and is not intended to cover the Fellows' continuing expenses at home for either themselves or their families.

- Fellows will be provided with a return economy class air-ticket to travel from their home country to complete the Fellowship.
- Amount
 - The amount of the stipend is determined in accordance with the established United Nations rates for each country. These rates are updated regularly and available on this website.
 - For the first month of the Fellowship, and for the first month of the second phase if applicable, Fellows will receive their stipend at the “Max Trav” rate. For all other months, Fellows will receive their stipend at the non-academic “Max Res” rate.
 - For United Nations – Nippon Foundation Fellows completing the 9-month Fellowship, the stipend rates for the second part of the Fellowship will vary according to the country in which the Host Institution is located.
- Book allowance
 - In addition to the stipend, the United Nations – Nippon Foundation Fellows (the 9-month Programme) will be provided with a Book Allowance of US\$100 per month for the phase two of the Fellowship (\$600 altogether). This allowance will be transferred to the Fellow either as a lump-sum payment, or on a monthly basis with each stipend payment.
