The National Productivity Organization (NPO), Ministry of Industries & Production, Government of Pakistan in collaboration with Asian Productivity Organization (APO), Japan announced opportunities for the citizens of Pakistan through competitive process for the following program:

- i. **23-CP-47-GE-TRC-A: Development of Public-sector Productivity Specialists, by Philippines & APO, Japan** from 10 July 2023–14 July 2023 (three hours' session per day), Virtual / Digital Session, **(NPO Deadline: 12 June 2023)**.

4. Case of only shortlisted nominee's will forward to APO, Japan for further evaluation. The final selection of nominee's rests with the APO screening committee and is not challengeable.

5. Processing Fee (Prerequisite) Non-refundable: PKR 5,000/- per applicant for Public Sector and PKR 8,000/- per applicant for Private Sector. Fee payment receipt in both cases either cash deposit in bank or online payment should be attached with APO Biodata Form (bank details are available on NPO website).


6. In case of selection participants will participate in the program virtually using their own devices, applications and internet Connections, etc.
