- Original scanned Fee payment receipt. (Prerequisite)

4. The final selection of nominee's rests with the APO screening committee and is not challengeable and only shortlisted nominations will be forwarded to APO screening committee.

5. Processing Fee: PKR 4,000/- for Public Sector per applicant and PKR 6000/- for Private Sector per applicant (Non-refundable). Fee payment receipt in both cases either cash deposit or online payment should be attached with APO Biodata Form.


6. In case of selection participants will participate the program virtually using their own devices, applications and internet Connections, etc.
