# WHY PARTICIPATE IN HORIZON EUROPE

Horizon Europe is the EU's 7-year flagship funding programme (2021-2027) for research and innovation.

The European Union is a world leader in research and innovation, hosting some of the best universities and most innovative companies in the world. Europe offers exceptional opportunities to researchers all over the world to collaborate with European research teams through the Horizon Europe programme.

In 2021, the European Union updated its strategy for international cooperation in research and innovation, presenting a new <u>Global Approach</u> based on openness to the world, shared values and principles, and focusing on global challenges, especially the green and digital transitions, health and innovation. This strategy is reflected in Horizon Europe, where the majority of calls for proposals are open to any company, researcher, university, non-governmental organisation, etc. regardless of their place of residence or establishment<sup>1</sup>.



Such rules are specified in the calls for proposals concerned. In addition, information on relevant EU sanctions can be found in the EU Sanctions Map.

#### HOW TO PARTICIPATE IN HORIZON EUROPE



#### How can you participate?

Collaborative projects: most EU support is allocated to collaborative research projects carried out by consortia of organisations working together on specific research areas. Organisations from anywhere in the world can participate, but consortia must include at least one organisation established in an EU Member State and at least two other organisations established in different EU Member States or countries associated to Horizon Europe.

Individual researchers: The European Research Council and the Marie Skłodowska-Curie actions offer unparalleled opportunities for researchers who want to work in Europe. If you are considering applying for these, you should contact your choice for a potential host institution in advance.

# Are you eligible for funding?

Researchers and organisations established anywhere in the world can participate in Horizon Europe. In addition, some may be eligible for EU-funding including:

- C Organisations established in the European Union or in a country associated to Horizon Europe, are automatically eligible for funding.
- © Organisations established in some 110 low- and middle-income countries are eligible for EU-funding.
- Organisations established in other countries can still be eligible for EU funding when this is explicitly stated in the relevant call for proposals/topic<sup>2</sup> or when their participation is considered by the European Commission to be essential for carrying out the action3.
- Individual researchers wishing to work in the EU and Horizon Europe associated countries, could in general also be eligible for funding, through their host institutions, regardless of nationality – in European Research Council actions and, depending on the type of actions they apply to, in the Marie Skłodowska-Curie actions (some of which require international mobility of the researcher).

Horizon Europe includes a new 'associated partner' status, similar but with several improvements compared to the 'international partner' status under Horizon 2020, to simplify the participation of research organisations in countries outside the EU which are not eligible for funding, and which bring their own financing.

The link to the submission system is available if the status of the call is open.

A login with your EU Login account is required.

Review partnership and other eligibility requirements of a call. Publish your partner search request or offer, select a topic on the Search Funding and Tenders page: Get more help here.

Use the Partner Search to find an organisation.

REGISTER YOUR ORGANISATION

Your organisation will need a 9-digit Participant Identification Code (PIC) as a unique identifier of your organisation. Your organisation may already be registered. Check here or register.

6 FOLLOW UP ON YOUR PROPOSAL

An evaluation committee with independent experts reviews the proposals. Following the evaluation, applicants receive a letter informing them about the outcome of their proposal and an evaluation report generally no later than 6 months after the call deadline.

National Contact Points (NCPs) are your local sources of advice and guidance. They provide practical information and assistance on all aspects of participation in Horizon Europe.
