Admission Regulation for Foreign Nationals in Undergraduate Programs

Applications in the prescribed online form (available at www.cuet.ac.bd/fsc) are invited from foreign nationals for admission into the undergraduate programs in all related degree offering departments of the Chittagong University of Engineering & Technology (CUET). The online application deadline is 30 April 2025 for admission into the 2024-25 academic session undergraduate courses of the University.

1. Eligibility Criteria

- (a) The candidates, except Bangladeshi nationals, who completed 12 years of schooling/ GCE "A" level or its equivalent examination shall be considered as foreign students.
- (b) Applicants who passed GCE "O" Level examination or its equivalent examination on or after November 2020 with 60% or its equivalent grade.
- (c) Applicants who passed GCE "A" Level examination or its equivalent examination on or after November 2022 with 60% or its equivalent grade.
- (d) Candidates must have passed the GCE "A" Level examination or its equivalent examination with minimum "A" grades or 70% marks in Physics, Chemistry and Mathematics. If the transcript contains both letter and numerical grades, then the letter grade will be considered.
- (e) Candidates passing the GCE "O" Level must earn minimum of "B" grade in at least four subjects (including Mathematics, Physics and Chemistry) in GCE "O" Level examination.
- (f) Candidates willing to be enrolled in Biomedical Engineering Department must have obtained a minimum of "B" grade or 60% marks in Biology in GCE "A" level.

2. Number of Seats

The total number of seats for foreign students in undergraduate program in an academic session is 50 (fifty).

3. Procedure for Submission of Application

An application for admission must be submitted online by the applicant to the Registrar, CUET on or before 30 April 2025. After receiving the applications, the Admission Committees of CUET will select the eligible candidates for Admission in order of merit. Authority will send the provisional list of selected candidates to the Ministry of Education for final approval. The Ministry of Education will examine the student's application for government approval and then forward it to the Registrar, CUET, to process it for admission. CUET will then issue an offer letter to the applicant to process a student visa from the Embassy of Bangladesh in their respective country. Due to these required formalities to finalize the selection, it is advised that the students should apply well ahead of the deadline of 30 April 2025.

The relevant documents of educational qualifications (all certificates and transcripts), copy of passport, recently taken passport-size colour photograph and signature of the candidate would be necessary to submit the application form.
