General Terms & Conditions

1. The Terms & Conditions are as under:

No tender will be considered if: -

- a) Received without required documentation or found incomplete.
- b) Received later than the date and time fixed for Tender submission.
- c) The Tender is unsigned/ unstamped.
- d) The Tender is singed/stamped by the unauthorized agent of the Firm/company.
- e) The Tender is from a firm which is blacklisted or in litigation of some sort with any Public-Sector Organization.
- f) The Tender is received by telephone/telex/fax/telegram.
- g) Tenders received without earnest money.
- h) In contradiction with the specification given by the CUI.
- 2. Firms/companies/agencies, who are on Active Taxpayers List (ATL) of FBR, both GST and Income Tax are eligible to apply.
- 3. Bidders will have to produce the proof of being a Tax Filer with FBR.
- 4. Income tax as applicable and announced by the Govt. of Pakistan will be deducted at source.
- 5. The payment will be made after successful completion of all task/job assigned.
- 6. The EoI must accompany earnest money as mentioned in the tender notice in the form of Call Deposit/Bank draft (refundable) drawn in favor of COMSATS University Islamabad.
- 7. Bid should be valid for 90 days.
- 8. Any attempt by a bidder to influence in the examination, evaluation, comparison, and post qualification of the Bids or Contract award decisions may result in the rejection of its bid.
- 9. CUI reserves the right to accept or reject any or all tenders as per PPRA Rules 33.
- 10. No advance payment will be permissible.
- 11. Applicable Taxes will be deducted at source/as per rules. In case of exemption, please mention and attach the proper documentation duly verified from the concerned tax authorities/FBR; however, if CUI will be final authority to accept or reject the exemption certificate and the vendor may claim refund from Tax Authorities/FBR.
- 12. In case of any holiday is announced by the Govt. OR any other unforeseeable circumstances that prevent the tender from being opened on the date announced (Force Majure), the tenders will be opened on the VERY NEXT WORKING DAY. Time and venue of the tender will remain as mentioned in the tender notice.
- 13. The documents prepared by the Bidder as well as all correspondence and documents relating to the Bid shall be in English only.
- 14. The currency of the quotation would be in Pakistan Rupees only.

- 15. Any proposal/tender received by CUI after the deadline will be returned unopened to bidder concerned. Delays in the mail or courier, delays of person in transit, or delivery of a proposal to the wrong office shall not be accepted as an excuse for failure to deliver a proposal at the proper place and time. It shall be the bidder's responsibility to determine the manner in which timely delivery of his proposal will be accomplished either in person, by messenger or by mail to the concerned office.
- 16. Do not submit any other document other than demanded.
- 17. No request for correction will be entertained after opening of the bid.
- 18. In case of signing of any Contract with CUI., the successful bidders shall be responsible to arrange the stamp paper as well as attestation from the Notary Public.
- 19. The Complete Design (CDR/Printable Format) along with all fonts used in the design must be submitted to CUI in CDs/DVDs/USB.
- The agencies must be willing to work with CUI official in CUIT premises, if and when required. The Designer must be willing to bring his computer/laptop/printer to CUI, if required.
- 21. In case the successful bidder fails to supply the design(s) within the given deadline AND the delay is fault of the designer, 1% per day, of the total price will be deducted for upto a total of 10% (10 Days).
- 22. If delay is beyond 10 days, CUI will decide whether to extend the time, in which case the penalty will be 2% per day, of the total cost (Day 11 onward). CUI may also consider Cancellation of Work Order AND/OR dis-qualify the bidder, removed from Pre-Qualification List AND/OR forfeit the Earnest Money AND/OR impose penalty (not exceeding the security amount).
- 23. Top 04 agencies will be pre-qualified for the following services. CUI is authorized to split the work in the pre-qualified agencies as it deems fit.
